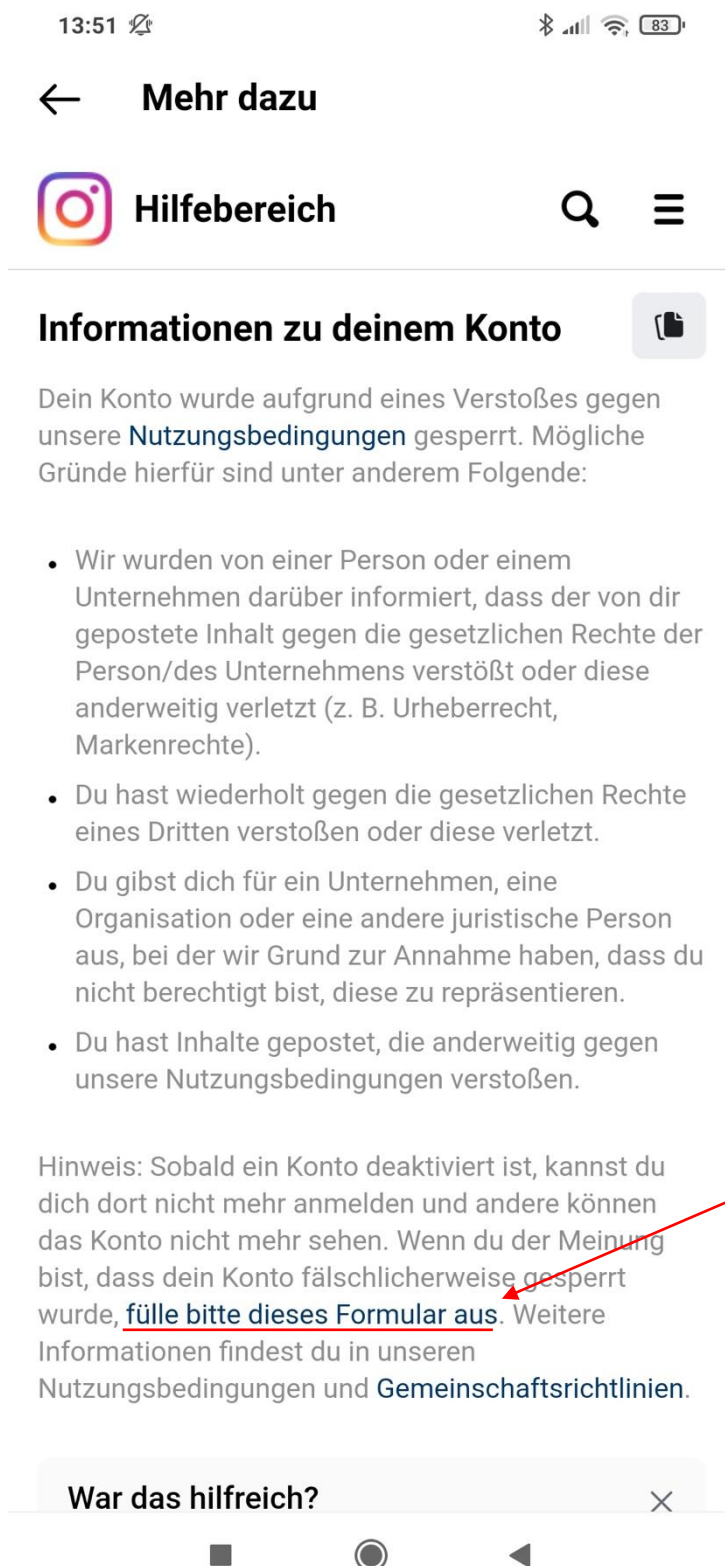


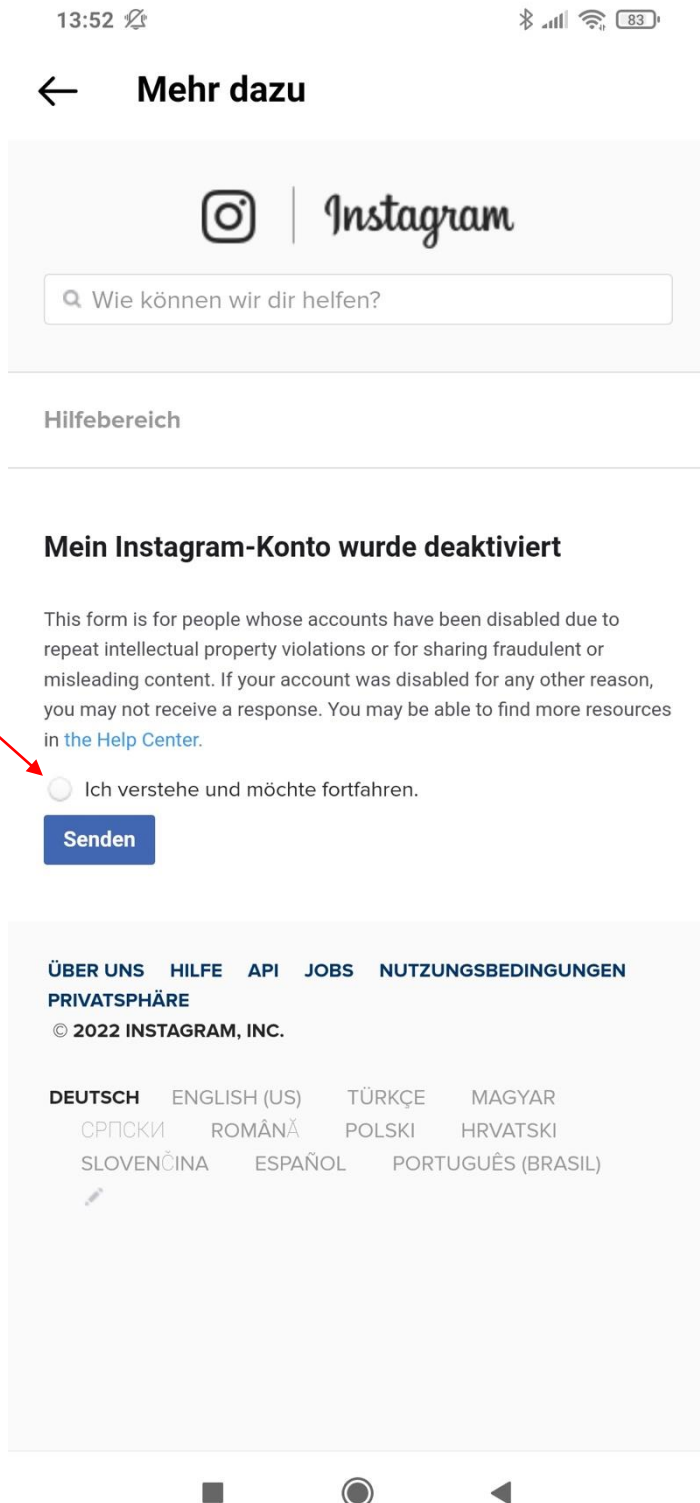
REACTIVATION OF INSTAGRAM ACCOUNT
